MINUTES OF A MEETING OF LLANSTADWELL COMMUNITY COUNCIL HELD ON TUESDAY 13TH JANUARY 2015 AT 7.00PM AT THE HAZELBEACH COMMUNITY MISSION HALL

1563 <u>DECLARATIONS OF INTEREST</u>

There were no declarations of interest.

1564 CHAIRMAN'S ANNOUNCEMENTS

The chair advised that she had not attended any functions during the past month.

1565 REPORT OF COUNTY CLLR PAUL MILLER

Cllr Miller was not present and no report had been sent to the clerk.

1566 MINUTES OF THE LAST MEETING

The Minutes of the meeting held on 9th December 2014 were proposed and seconded. They were agreed as a true record.

1567 MATTERS ARISING FROM THE MINUTES OF THE LAST MEETING

Minute 1552 a) The clerk had obtained a quote for the insurance of the play equipment at Waterston Play Park as well as the public liability insurance which was £138.24 pro rata until the end of the policy or £360.04 for a full year. It was agreed that cover be taken up immediately and that the Waterston Group be asked to reimburse this sum. It was also suggested that our agreement with regard to the play area should be formalised in written form. The clerk would contact Mark Sanderson by e-mail with regard to this.

Minute 1552 b) Natural Resources Wales had investigated the area in Hazelbeach where kerosene was reported as leaking and had found nothing to note. They will, however monitor the situation regularly.

Minute 1555 – Quiet Lanes – the clerk had made enquiries with the relevant officer at PCC and was told that if this Council puts a case forward for Quiet Lane designation they will investigate it and let us know the outcome. It was

agreed that Cllr M Howells would conduct a small sample survey locally to see what the locals think of this idea.

Minute 1560 Hazelbank Play Area – Cllr Wilson reported that the wooden structure and the plastic slide had been removed and disposed of. The swings were being refurbished by Alliance Lifting and Cllr P Roberts is to repair the seat and bolts under the slide. The dips will be filled in and the fencing posts will be fixed.

Minute 1562 – Any Other Information d) The County Council had failed to find someone prepared to have the noise monitoring equipment in their home. Councillors offered to ask residents in the vicinity if they were prepared to do this. Cllr G Wilson advised that he had attended a liaison meeting the previous evening and had ascertained that 33hours of flicker from the blades was allowed. Anything above that and they would be turned off. Councillors commented that the flicker was affecting people on the other side of the haven and suggested that Pembroke Dock Town Council be asked if they know of residents affected by flicker. We should keep on complaining until something is done.

1568 PLANNING APPLICATIONS

The following planning applications were considered:

- a) 7 Lighthouse Drive extension to conservatory at rear **14/0880/PA**. It was agreed to **support this application**.
- b) Agricultural Access near 33 Phillips Walk **14/0797/PA.** It was agreed **not to support** this application on the following grounds:
 - I. That the size of the access is out of keeping with the area of land it serves.
 - II. That there is already an existing access.
- III. The access is on a corner of a narrow road and visibility is limited on exiting the land.
- c) Approval of Reserved Matters for the erection of a dwelling on plot N.E. of Ty Pencraig, Newton Road, Llanstadwell 14/0856/PA. It was agreed **not to support** this application on the following grounds:
 - I. The contemporary design is out of keeping with other properties in the area.
 - II. The nature, location, siting and scale of the proposed development is not compatible with the capacity and character of the site and the area within which it is located.
- III. It would result in a significant detrimental impact on local amenity in terms of visual impact, loss of light and privacy.
- IV. It would adversely affect the landscape character including the special qualities of the Pembrokeshire Coast National Park and neighbouring authorities.

A variation of planning permission to allow holiday occupancy was granted for Lodge Gate, Hazelbeach – 14/0232/PA.

1569 CORRESPONDENCE

The following correspondence was received:

1570 PROPERTY AUDIT/ASSET REGISTER

The clerk had circulated the list of property as it appears in the insurance schedule and most items were correct. Some values were amended to reflect inflation and councillors will check on the gates etc within their own areas as some are the responsibility of the National Park. The clerk was asked to check with Mrs M Wiltshire as to whether the bus shelter in Jordanston had been removed by PCC and then to amend the asset register.

RESOLVED: That the changes as agreed be made to the asset

register and that checks on gates and bus shelters be

made.

1571 BUS ROUTES TO SCHOOLS

Councillors commented on the fact that the 8.00am bus to Milford Haven no longer travels via Hazelbeach meaning that those working in Milford Haven or going to school could not get there on time. The clerk had spoken to Cty Cllr Paul Miller who had suggested that a case be put forward to re-instate the 8.00am bus, however he did state that the service was dropped because it was under-used and it was unlikely to be reinstated. It was agreed that no further action be taken on this matter.

RESOLVED That no further action be taken on this matter.

1572 ANNUAL DINNER

It was agreed that the Council dinner be held at The Bar at Neyland Marina on Friday 6th March.

1573 UPDATE ON BANK ACCOUNTS

A draft budget had been set recommending expenditure of £15,538.50 and income of £14,783.20 giving a shortfall of £755.30. However it was agreed to reduce the Insurance budget by £400 to £1,200. A draft precept was set of £11,596.20 which equates to £30 per household.
